

CERTIFICATE OF ACRES PLANTED

APPLICATION & REPAYMENT AGREEMENT: APPLICANTS USING SECURITY OTHER THAN PRODUCTION INSURANCE (PI) & OUT OF PROVINCE OF ONTARIO APPLICANTS (STORABLE ONLY)

IMPORTANT: Must be completed and submitted to ACC prior to July 31st, otherwise the producer will be declared in default resulting with loan payable immediately. This form does not apply to single installment loan advances.

If you are using security other than Production/Crop Insurance (i.e. AgriStability) to secure your products or are an out of Province of Ontario applicant, this form must be completed after planting has been completed to certify your acres planted.

Should the actual/final seeded acreage report or the production demonstrate that the acreage seeded was not sufficient to justify the intended Eligible Advance under the first (1st) instalment issued to the Producer(s), and the difference is equal to or higher than \$10,000 or 10% (whichever is greater), the Producer(s) is/are in an overpayment situation and ACC shall, notify the Producer(s) that he/she/they have thirty (30) calendar days to repay the difference between the first (1st) instalment and the Eligible Advance or, if eligible, make application for an advance on another commodity and have the proceeds applied to the deficit. Failing this, the Producer(s) will be declared in default.
